**NOTICE IS HEREBY GIVEN THAT THE ROCHESTER CITY COUNCIL** will hold a Public Hearing on the use of Community Development Block Grant (CDBG) funds. The Public Hearing will be held on **Tuesday, November 23, 2021 at 7:00 p.m.** in person & Zoom and can be joined by going to <https://us02web.zoom.us/j/85823232150> for the purpose of hearing public comments on the Community Development Block Grant (CDBG) Program Year 2022 application in the approximate amount of \$28,000 to retrofit existing asphalt or concrete paths that vary in width from 6.5 to 9 feet in width and replace them with asphalt or concrete 10-foot-wide paths to meet ADA compliance standards at Rochester Municipal Park.
