This permit is granted on the express condition that the size, number, color and construction of the sign(s) shall in all respects conform to Ordinances and Codes of the City of Rochester regulating signs, and may be revoked at any time upon the violation of any of the provisions of said ordinances or Codes.

The structural elements must not be concealed until they are approved by the Building Inspector and if illuminated, the Electrical Inspector.

SECTION 2208. SIGN PERMIT APPLICATION REQUIREMENTS

REVISED 01/01/2023

All applications for sign permits shall be made on forms provided by the Building Inspector and shall contain 18 complete color sets of the following minimum information for planning commission submittal; 3 complete sets for administrative submittal:

- A. A sketch indicating the location of the subject property and current zoning classification.
- B. A scale drawing of each sign, in the colors of the finished sign, indicating the size, shape, message, lettering style, and materials of the finished sign. (All required copies must also be in color.)
- C. Building elevation sketches showing the position and size of each sign on the building and the location and size of any existing sign(s) on the same structure.
- D. For free-standing signs, a site plan sketch showing the sign height, location of the sign on the site, and verifying compliance with all setback requirements.
- E. If the sign will be illuminated, plans shall include all details regarding the location, type of fixture, color of the illumination, and method of shielding the lighting equipment to prevent glare. Illuminated signs shall be located not less than one hundred (100) feet from a residential district.
